<sup>1</sup> **Alabama:** By order of the Commissioner of the Department of Revenue dated January 5, 2021, the deadline for motor vehicle registrations and property tax payments on motor vehicles and extended due to COVID-19. The measures include extending: 1) the deadline for vehicle registrations to the last business day of the subsequent month the registration was otherwise due for registrants where the county license plate issuing office was closed during the month the registration was originally due; 2) the 20-day registration requirement where the county licensing office was closed and the registrant didn't have access to it; 3) vehicle registrations and renewals under the International Registration Plan where the office was closed during the month the registration was originally due; and 4) penalty charges associated with registrations, renewals, and tax payments. The extension of time provided in the Commissioner's order is valid from Jan. 1 and will expire on June 30.

<sup>2</sup> **Alaska:** Alaska Governor Mike Dunleavy has issued a series of COVID-19 Outbreak Health Orders following the issuance of the Public Health Disaster Emergency Declaration effective November 16, 2020 due to the outbreak of the COVID-19 virus in the State of Alaska. Effective November 16, 2020 at 12:01am, Order No. 1, Suspension of Regulations and Statutes, suspends certain regulations and statutes to allow agencies to best address the COVID-19 emergency. The regulations and statutes set for in Appendix A to this order include Alaska Statute section 28.10.321(a), and as such there is a suspension of the requirement for a new owner of a vehicle to present certificates of title and registration properly endorsed to DMV, apply for a new title, and register the vehicle as upon an original registration.

<sup>3</sup> **Arizona:** In order to safely and efficiently serve customers during the ongoing health situation, the Arizona Department of Transportation Motor Vehicle Division will limit office visits to only those customers who need essential services that must be done in person.

<sup>4</sup> **Arkansas:** Ark. Code Ann. § 27-14-1004(a) imposes a late registration penalty of \$3.00 for each ten days a person fails to properly register a motor vehicle until the penalty reaches the same amount as the annual license fee of the vehicle, which may range from \$17.00 to \$30.00. Under Executive Orders 20-06 and 20-16, DFA has suspended until the COVID-19 emergency subsides the penalty under Ark. Code Ann. § 27-14-1004(a) for the late registration of a motor vehicle or the late renewal of a registration of a motor vehicle. DFA has also suspended until the COVID-19 emergency subsides the requirement under Ark. Code Ann. § 27-14-1015 and Act 465 of 1967, § 17 that a person provide proof of property tax assessment and payment of tax due for purposes of motor vehicle registration and renewal of registration.

<sup>5</sup> **California:** The California Department of Motor Vehicles on Thursday, June 11, will reopen its remaining field offices that were temporarily closed during the COVID-19 pandemic. With this phase of reopening, employees at 169 field offices will assist customers with current appointments at the specific office and limited transactions that require an in-person visit. Behind-the-wheel drive tests are not yet available, and the DMV continues to recommend that customers use its online services, expanded virtual services and other service channels to complete transactions, including eligible driver license and vehicle registration renewals. DMV announced on April 23, 2020 that it is waiving late fees and penalties for vehicle registration, extending expiring identification cards, temporary operating permits and motor carrier permits. DMV (1) waived late fees and penalties for vehicle registration renewals due between March 16 and May 31, 2020, and paid within 60 days of the original expiration date. The requirement to have current license plate stickers is also waived for vehicles with registration expiring between March 4 and June 30, 2020; (2) extended identification cards expiring on or after March 4, 2020, to be valid through June 22, 2020; (3) temporarily suspended for 60 days the requirement to submit a transfer of ownership within 10 days for vehicle transfers occurring on or after March 4, 2020, and the requirement to register a vehicle acquired or previously based outside of California within 20 days once registration becomes due; (4) allowed temporary operating permits that expire on or after March 4, 2020, to be valid until June 22, 2020; and (5) lengthened motor carrier permits expiring in March, April and May 2020 to June 30, 2020.

<sup>6</sup> **Colorado:** As the state's efforts to safeguard residents' health move forward, the Colorado Division of Motor Vehicles (DMV) has entered the final phase of its staggered office reopenings. During this final phase, the DMV has reopened all but one of its offices to Coloradans who have appointments. The only office which will remain unopened is the Trinidad Driver License Office which will remain closed until its stay-at-home order is lifted.

<sup>7</sup> **Connecticut:** Connecticut Department of Motor Vehicles has reopened select offices with service by appointment only. The Department resumed road testing services for driver's licenses as well as new vehicle registration services on June 30, 2020 at select DMV locations. Governor Lamont authorized DMV to extend renewal deadlines (license only) to reduce crowds at DMV branches; and is ordering a 180-day extension. DMV, with the approval of Governor Ned Lamont, is extending deadlines for expiring credentials. The change impacts credentials that expired between March 10, 2020 thru November 30, 2020. Late fees will be waived for qualifying credentials. Deadlines have been extended for the following DMV transactions: all licenses, permits and identification cards, including commercial driver's licenses; motor vehicle and boat registrations, emissions testing and retesting; and permanent disability placards.

<sup>9</sup> **District of Columbia:** The DC Department of Motor Vehicle will resume in-person services beginning Tuesday, June 23, 2020 as part of Phase Two. The public will be required to make appointments for most DC DMV services as the District continues efforts to mitigate the spread of the coronavirus (COVID-19). Beginning June 2, 2020, the Southwest Service Center will operate on an "Appointment Only" basis through Phase 1 of the District's reopening plan, and the following select in-person services will be available: First Time License and REAL ID Conversions; First Time Title and Registrations (no renewals); and Knowledge Testing. DMV has extended the expiration date for all documents expiring March 1 through the duration of the public health emergency, including driver licenses, identification cards, vehicle registrations, inspections, ticket payments and ticket adjudication responses, until 45 days after the health emergency concludes. All driver licenses, vehicle registrations, and vehicle inspections scheduled to expire have been granted a waiver without penalty until DC DMV reopens at full operating capacity.

<sup>12</sup> **Hawaii:** Safety inspection stations for commercial motor vehicles, (i.e., a motor vehicle that is over 10,000 pounds GVWR) are being performed but by appointment only. Safety check certificates and stickers expiring on or before May 31, 2020, will remain valid until August 31, 2020. All other safety checks that expire in 2020 will be valid for an additional 3 months after the 2020 expiration date. HDOT is extending the safety check waiver to minimize unnecessary face-to-face interactions and to provide enough time for Periodic Inspection of Motor Vehicle (PMVI) stations, counties, and people to conduct and process safety checks once the stay-at-home order ends. Motor vehicle registration fees and any applicable penalty fees for late registration have not changed. These funds are necessary to meet the local share of upcoming stimulus projects for road construction and maintenance. You can do renewals for registration by mail, online, or through available kiosks. In consideration of Governor Ige allowing the reopening of low risk businesses that take necessary precautions, the Hawai'i Department of Transportation (HDOT) is coordinating the reopening of stations for Periodic Motor Vehicle Inspections (PMVI or Safety Checks) starting Friday, May 15.

<sup>13</sup> **Idaho:** Effective immediately, the Idaho Transportation Department has also extended all Vehicle Registrations and Temporary Handicap Placards that are expired or will expire between March 1, 2020 and May 31, 2020, to be valid until June 30, 2020. This extension applies to all registrations issued at a county office (includes passenger, commercial, non-commercial, and farm registered vehicles). At this time, the extension does not apply to registrations issued directly by the department or Ports of Entry (includes Full Fee or IRP registered commercial vehicles). New issuances and renewals of these registration types can be done online. Effective immediately the Idaho Transportation Department is allowing all Idaho licensed vehicle dealers to issue 60 day temporary registration permits for any vehicles sold between March 17, 2020 and May 31, 2020. This allowance is only for dealership customers who have just purchased a vehicle from the same dealer issuing the temporary registration. Additionally, on October 29, 2020 the Idaho Transportation Department Division of Motor Vehicles announced that it is providing an extension on expiring vehicle registrations and driver's licenses. In an effort to reduce wait times at county DMV offices, non-commercial vehicle registrations and driver's licenses that expire between September and December 2020, now have until January 31, 2021 to renew.

<sup>14</sup> **Illinois:** The Illinois Secretary of State's Vehicle Services Department reopened on June 1, 2020, with a 120-day extension on vehicle registration renewal dates. On July 9, 2020, the SOS announced that expiration dates for driver's licenses/ID cards and license plate stickers have been extended an additional month – from Oct. 1, 2020, to Nov. 1, 2020. This new Nov. 1 extension also includes those who have July, August and September expiration dates. As a result, expired documents will remain valid until Nov. 1. Illinois EPA will resume vehicle emissions testing at most Illinois Air Team locations beginning June 1, 2020. All Illinois Air Team testing locations will be open with the exception of the Markham and Waukegan locations. Illinois EPA is recommending motorists with a March or earlier vehicle registration expiration date have their vehicles tested in the month of June. Vehicle registration expiration dates have been extended without penalty by at least 90 days, allowing motorists to wait to have their vehicles tested and renew vehicle registrations. Illinois Secretary of State Jesse White announced on Friday, December 4th that driver's services facilities statewide would remain closed for in-person transactions until January 5, 2021.

<sup>15</sup> **Indiana:** Beginning the week of June 15, branches will be open for walk-in service and will continue to support scheduled appointments. Pursuant to Executive Order, effective March 19, 2020 and for the following 60-day period, administrative penalty (late) fees are waived (including for late vehicle title transactions and registration renewals) and the Indiana Bureau of Motor Vehicles is not required to operate a branch in each of Indiana's 92 counties. Effective March 31, 2020, Indiana Department of Revenue (DOR) Commissioner Bob Grennes has waived several Motor Carrier Services (MCS) requirements until May 22, 2020. The waivers affect: (1) Out-of-state motor carriers who are delivering COVID-19 supplies do not need to obtain trip permits or register with the International Registration Plan (IRP) or the International Fuel Tax Agreement (IFTA) before entering Indiana. Upon request, drivers must be able to prove they are hauling food, goods, medical supplies, other equipment and supplies to address the public health threat posed by COVID-19. This waiver will expire on May 22, 2020; (2) IRP or Base Plate registrations (BPR) expiring on March 31, 2020, or April 30, 2020, will not expire until May 31, 2020. Also, an Indiana-based IRP or BPR registrant may delay a registration renewal and/or payment for registrations effective May 1, 2020, until May 31, 2020; and (3) Any delayed IRP renewal registrations and/or payments must have an effective renewed IRP registration submitted to DOR by June 1, 2020. All Hoosiers with expired driver's licenses, permits, state identification cards, and vehicle registrations need to complete renewal transactions before July 1 to avoid paying an administrative penalty fee. Title transactions and new vehicle registrations must also be completed before July 1.

<sup>16</sup> **Iowa:** Beginning March 24, Iowa DOT operated service centers are open by appointment only. Walk-in customers will not be served. Customers with essential service needs will be given priority scheduling. All other customers will be scheduled after May 1. If your vehicle registration expired Jan. 16, 2020 or later you do not need to renew your registration at this time. If your registration was due on Jan. 31 through June 30, you are not required to renew at this time and will not be assessed any penalty for failing to renew. Your new expiration date will be considered Jul. 28 and you will have a grace period for the month of August. If you do not pay your registration on Aug. 31 or before you will begin accruing late penalties, beginning Sept. 1. You will not be assessed late

<sup>17</sup> **Kansas:** From March 24, 2020 through July 7, 2020, extensions to driver's licenses and vehicle registrations were made through Executive Order No. 20-12 and subsequently Executive Orders Nos. 20-36 and 20-49 signed by Governor Laura Kelly. All driver's license renewals and vehicle registrations extended by this Executive Order must be completed within 60 days of the expiration of Executive Order 20-36. On July 8, 2020, Governor Laura Kelly signed Executive Order No. 20-55 which provides extensions to apply for certificates of title, registration, or vehicle transfers for new or used vehicles: 1) to Aug. 31, for vehicles purchased between Jan. 1 and Jan. 31; 2) Sept. 30, for vehicles purchased between Feb. 1 and Feb. 29; 3) Oct. 31, for vehicles purchased between March 1 and March 31; 4) Nov. 30, for vehicles purchased between April 1 and April 30; and 5) Dec. 31, for vehicles purchased between May 1 and May 31. Moreover, any temporary, 60-day Kansas permits for motor vehicles purchased after January 1, 2020, through May 31, 2020 are extended. Kansas residents who have purchased a new or used motor vehicle on or after January 1, 2020, and are operating with a valid, extended 60-day permit, may continue to use such temporary tag beyond the 60-day period and the State permit shall continue to authorize road use subject to the deadlines indicated above. Vehicle registrations with an expiration date of March through June 2020 must be renewed by Nov. 14, 2020. Vehicle registration renewals from July 2020 forward must be renewed in the regularly scheduled month. These extended deadlines were reaffirmed but with no substantive changes by Executive Order No. 20-66 signed by Governor Kelly on September 23, 2020.

<sup>18</sup> **Kentucky:** On July 2, 2020, Gov. Andy Beshear announced changes to a previously issued official order that temporarily granted a 90-day extension for select driver and motor vehicle documentation that expired while local and state government issuance offices were closed due to COVID-19. Provisions under official orders authorizing circuit court clerks to accept driver's license renewal applications remotely were also extended for an additional three months. The grace period for all vehicle and vessel registrations or disabled parking placards administered by county clerks or the Kentucky Transportation Cabinet will continue with no penalties charged through close of business on October 6, 2020. <sup>19</sup> **Louisiana:** Beginning Monday, May 18, 2020, the Office of Motor Vehicles will begin providing limited office services at eleven locations across the state. The limited services include the issuance/renewal of driver licenses and/or identification cards, ordering a duplicate title, renewing vehicle registrations, and title transfers. Those locations are Alexandria, Baton Rouge – Independence Blvd, Harvey, Houma, Lafayette, Lake Charles, Livingston, Mandeville, Monroe, New Orleans – Veterans Hwy and Shreveport. Beginning Thursday, May 21, 2020, OMV will add 8 more offices to the list of open locations across the state: Franklinton, Greensburg, Jennings, Jonesville, Natchitoches, Ruston, St. Francisville, and Vivian. Beginning Friday, May 22nd, 2020, the Office of Motor Vehicles will add 10 more offices to the list of open locations across the state: DeRidder, Donaldsonville, Golden Meadow, Gramercy, Minden, Napoleonville, Oakdale, Plaquemine, West Monroe, and Winnsboro. Throughout the limited service, licensing and registration requirements remain waived through Governor John Bel Edwards' Emergency Proclamation 59 JBE 2020 dated May 14, 2020:

- The expiration date of temporary registration plates issued pursuant to La. R.S. 47:519 and La. R.S. 47:519.2 which expired on or before March 9, 2020 remains suspended until June 30, 2020.
- The expiration date of license plates issued pursuant to La. R.S. 47:462, et seq., which expired on or after March 9, 2020 but before May 15, 2020 remains suspended until July 31, 2020.
- The expiration date of an apportioned registration issued under the International Registration Plan which expires June 5, 2020 remains suspended and the expiration date remains extended to June 30, 2020.
- For purchasers of used vehicles, purchased from a private individual on or after February 4, 2020 but before June 5, 2020, the 60-day grace period provided for in La. R.S. 32:707(H) for citations for failure to have a current registration and license plate is extended until June 30, 2020.
- Penalties and interest due on state and local sales and use taxes collected by the Office of Motor Vehicles which began on or after March 9, 2020 are suspended and are waived until June 30, 2020.

<sup>20</sup> **Maine:** The Bureau of Motor Vehicles reopened to the public, by appointment only, on Monday, June 1, 2020. The Maine Governor June 26 issued an executive to modify the meaning of 'vehicle' as provided in Executive Order 53-A FY 19/20 for excise tax purposes. The order includes measures: 1) amending the meaning of 'vehicle' to include a motor vehicle and trailer; 2) providing that 'registration' includes temporary registrations; and 3) lifting the interim suspension on statutory all-terrain vehicle, snowmobile, and watercraft registrations. The order took effect June 26. On May 26, 2020, Gov. Janet Mills signed Executive Order #53-A, which sets guidelines for vehicle registrations during this state of emergency. According to this order, if a person can register their vehicle through their municipality or Bureau of Motor Vehicle Office they are advised to do so as soon as possible. If a registrant's municipal office or the Bureau of Motor Vehicles office is processing vehicle and trailer registrations, the registrant must complete this transaction no later than July 11, 2020 or by the deadline set by their municipality, whichever is sooner. If the municipality is not processing registrations during the BMV closure, and the applicant cannot complete the transaction online using the Rapid Renewal service (in participating towns), the registration is extended or exempt until such time as the municipal office or BMV can perform the work. For those who have purchased a motor vehicle or trailer in a private sale, or received the vehicle by transfer of ownership, and subsequently cannot register by virtue of their municipality and BMV being unable to perform that function, they are advised to print and retain a new "temporary registration" letter. This letter will serve as a temporary registration until such time that the municipality or BMV is able to complete the registration process. This applies to registrations issued by municipalities or the Bureau of Motor Vehicles, and also to temporary registrations issued by dealers. families, and businesses for transportation, work and commerce during the emergency. These registrations can be renewed after the emergency ends. Registrations issued by a municipality, including temporary registrations, are deemed extended until 30 days following the termination of the state of emergency pursuant to P.L. 2019, ch. 617, F-1, emergency laws approved by the Governor on March 18, 2020. Other registrations, including temporary registrations, will be extended until 30 days following the termination of the state of emergency pursuant to the emergency provision of 29-A MRSA 405(4). Linked below is a temporary registration letter that may be presented to law enforcement to evidence the extension of temporary registrations pursuant to the executive provision. A second set of registration extensions were provided by Maine's governor by Executive Order No. 15 FY 20/21 on October 19, 2020.

- Vehicles purchased between January 1, 2020 through March 15, 2020 and vehicles with registrations that expired before March 15: Register immediately.
- Vehicles purchased between March 15-May 31, 2020 and vehicles with registrations that expired during that period: Register no later than Dec. 18, 2020.
- Vehicles purchased June 1, 2020 through September 30, 2020 and vehicles with registrations that expired during that period: Register no later than Feb. 16, 2021.
- Vehicles purchased on or after Oct. 1, 2020 and vehicles with registrations that expired during that period: Register as soon as possible, in accordance with Maine motor vehicle law:
- Temporary plates on new vehicles are valid through the expiration date on the plate and the vehicle must be registered prior to the temporary plate's expiration to avoid penalties.
- Vehicles with registrations that expire in October should be registered ASAP or no later than Oct. 31 to avoid penalties.

<sup>21</sup> **Maryland:** The Maryland Department of Transportation Motor Vehicle Administration (MDOT MVA) has reopened branch offices to the public by appointment only beginning on Monday, June 22. Governor Hogan has ordered an extension of all driver's and business licensed, identification cards, permits, registrations with expiration dates beginning March 12 until the end of the state of emergency. As a result, they will not expire until 30 days after the state of emergency has been lifted. With respect to penalties and fees for late titlework and registrations, Md. Code Ann. Transp. § 13-808(1) provides that MVA is not able to issue a certificate of title for a vehicle until the paperwork and excise tax is paid to MDOT MVA. It is also a requirement that the excise tax and paperwork must be submitted within 30 days of the delivery of the vehicle. Governor Larry Hogan declared a state of emergency on March 5, 2020, in response to the COVID-19 pandemic. MDOT MVA in consultation with the Maryland State Police Automotive Safety Enforcement Division will accept an MSI that is expired beyond the 90-day period but not to exceed 120 days. This will be valid for MSIs processed on or after March 5, 2020. These transactions will need to be walked into MDOT MVA Branch Office for processing. Inspections expired for 121 days or more will need to go through the reinspection process. MDOT MVA is currently waiving the 60-day Excise Tax credit requirement until 30 days after the Governor's Executive order is lifted. Transactions of this type will need to be walked into a MDOT MVA Branch Office for processing. On October 13, 2020, MDOT MVA announced the reopening of all Vehicle Emissions Inspection Program (VEIP) stations statewide beginning October 19, 2020.

<sup>22</sup> **Massachusetts:** Only the following 8 RMV centers will be open effective March 18th until further notice: Boston/Haymarket; Brockton; Fall River; Lawrence; Pittsfield; Plymouth; Springfield; Worcester; Milford - Commercial Driver's License/Permit ONLY; Wilmington - Commercial Driver's License/Permit ONLY. Effective Friday, March 27th, the RMV will be enforcing a strict no walk-in policy at its eight Service Centers open to the general public. The only transactions that will be processed at service centers are those that require an in-person transaction, including Commercial Driving Licenses or Permits (CDLs / CLPs), some new registrations, out of state conversions and new Mass IDs. By notice of May 26, 2020, all passenger plate registrations that have expired or will expire in March, April, and May 2020 have been extended until July 31, 2020. The RMV has also applied a 30-day extension to registrations that expire in June, which will now expire on July 31, 2020. Registration renewals can continue to be performed online at Mass.Gov/RMV during this time. No additional extensions will be applied, and inspection stations are open at their discretion within the public health guidelines to perform this work.

<sup>23</sup> **Michigan:** As enacted into law effective July 1, 2020, Senate Bills 876, 877, and 878 (2020 Michigan Public Acts Nos. 127, 128, and 129) provide that state ID cards, vehicle registrations, and driver licenses, permits, endorsements, and certifications that expire on or after March 1, 2020, are valid until September 30, 2020. This includes temporary registrations and registrations for those vehicles that are used for commercial purposes and commercial registrations issued under the International Registration Plan. As enacted into law effective October 28, 2020, House Bill 6192 (2020 Michigan Public Act No. 241) amends the Michigan Vehicle Code to provide that certain licenses and registrations that expire on or after March 1, 2020, are valid until December 11, 2020 or as specified (previously, until September 30, 2020 or as specified). The bill also provides that late fees cannot be assessed on vehicles whose registrations expire on or after March 1, 2020, but are renewed before December 11, 2020 (previously, September 30, 2020).

<sup>24</sup> **Minnesota:** Minnesotans will once again be able to access the majority of driver and vehicle services starting May 19 at 8 a.m. DPS-DVS is reopening 14 exam stations to serve customers statewide on May 19. The Brainerd exam station was scheduled to reopen May 19, but will be delayed due to a fire in Brainerd City Hall. These locations will reopen: St. Paul, Arden Hills, Anoka, Eagan, Plymouth, Rochester, Mankato, Marshall, Willmar, Detroit Lakes, St. Cloud, Duluth, Grand Rapids, and Bemidji. Although vehicle registrations have not been extended, Gov. Walz signed a bill into law March 28 that provides an extension for Minnesotans whose driver's licenses or ID cards expire during the peacetime emergency. The law extends the expiration date for any valid driver's license, instruction permit, provisional license, operator's permit, limited license, and farm work license that would expire during the peacetime emergency. In addition, Tax Commissioner Tony Fulton has also issued waivers of any penalties and interest for failure to timely pay sales taxes associated with late titling or registration of motor vehicles, all-terrain vehicles, utility-type vehicles, and motorboats. This relief is granted automatically, there is no need to apply for the waiver. This relief is provided with respect to purchases or leases made on or after March 1, 2020, and ends 30 days after the Governor rescinds Executive Order 20-05. On July 2, 2020, Nebraska's Governor issued Executive Order No. 20-30 rescinding the temporary waiver provided to taxpayers under Executive Order No. 20-05 to apply for motor vehicle registrations and pay motor vehicle sales tax for sales and use, and excise tax purposes. Executive Order 2020-016 requires the Motor Vehicle Division of the New Mexico Taxation and Revenue Department to temporarily waive fees and penalties incurred due to the social distancing recommendations that closed many MVD offices until further notice. The waiver will continue through the period MVD field offices are closed and for a reasonable period of time after, to be

<sup>33</sup> **New York:** All DMV Offices are closed effective March 23, 2020. Beginning Monday, June 1, state-run DMV offices in the counties of Albany, Onondaga, Nassau, Suffolk, Rockland, Westchester and the five boroughs of New York City will begin to process vehicle registrations and other transactions by mail, and beginning June 4, will accept transactions through secure drop boxes located at each office. As regions enter phase 3 of reopening, DMV will offer limited in-person transactions in state-run DMV offices by reservation only, prioritizing critical services, and will resume road tests for all drivers at that time. Until then, there will be no in-person transactions in any DMV office and reservations will only become available as regions enter phase 3. <sup>34</sup> **North Carolina:** On May 4, 2020, Governor Cooper extended expiration dates for N.C. Division of Motor Vehicles credentials by enacting into law Session Law 2020-3 (Senate Bill 704). People whose credentials expired between March 1, 2020 and Aug. 1, 2020 have been given a one-time, five-month extension (from the original expiration date) to renew driver licenses and handle vehicle registrations. Any fines and fees related to expired credentials are being temporarily waived. Customers who already paid a \$15 fee for a late renewal in March or April will be reimbursed. This language does not change the original expiration date of the driver license or vehicle registration renewal; it only provides a one-time extension. The five-month extension applies to any credential that expire on or after March 1 and before August 31st, including temporary vehicle registrations and vehicle inspection authorizations. Based on guidance from the North Carolina Department of Revenue: (1) a valid inspection will be required before a renewal can be processed; (2) the renewal month will not be changed, meaning that if the registration expired in March 2020, the citizen will have to renew again in March 2021; (3) late fees apply beginning the day after the 5-month extension deadline, and interest 15 days after the 5-month extension deadline; (4) limited registration plates (LRPs) that expire and accrue interest during the months covered by the order will have interest waived; and (5) if a registrant has a renewal or LRP that falls within the months covered by the order and has already paid penalties and/or interest on a late payment, he or she will they receive a refund.

<sup>36</sup> **Ohio:** On March 27, 2020, Governor Mike DeWine signed Sub. H.B. 197, which states that Ohio licenses (including driver license, CDLs, and registrations) expiring during the declared State of Emergency shall remain valid until either 90 days after the declared emergency ends, or December 1st, 2020, whichever comes sooner. The State of Emergency was declared on March 9, 2020. Due to the ongoing pandemic, on November 24, 2020 Ohio Governor Mike DeWine signed Ohio House Bill 404, which extends the expiration date of driver licenses (DL), identification cards (ID), and vehicle registrations beyond December 1, 2020. Now, if a customer's expiration date on their DL, ID, or vehicle registration is March 9, 2020, to April 1, 2021, the expiration date has been automatically extended and will remain valid until July 1, 2021.

<sup>38</sup> **Oregon:** DMV has been expanding the number of offices open to the public by appointment only as well as the types of transactions that can be completed, and the Oregon Department of Environmental Quality reopened several of its Portland metro locations on Tuesday, June 16, 2020. The Department of Transportation has partnered with Oregon law enforcement agencies to exercise discretion in their enforcement of driver licenses, vehicle registrations and trip permits that expire during the COVID-19 emergency. Oregon State Police, Oregon Association of Chiefs of Police, and Oregon State Sheriffs' Association have agreed to support a grace period for enforcing expired credentials. The Oregon law enforcement citation moratorium for expired driver licenses, permits, ID cards, and vehicle registration has been extended through Oct. 1. The grace period is intended to allow Oregon residents to continue driving while they are waiting for an appointment and DMV works through the backlog due to COVID-19 restrictions. Law enforcement can verify the status of a driver or vehicle electronically during a traffic stop.

Governor Kate Brown signed into law Senate Bill 1601 on July 7, 2020. The bill passed the Oregon Legislature during the 1st Special Session of 2020 (2020 Or. Laws ch. 15 (Spec Sess.)). Section 21 of Senate Bill 1601 creates a moratorium for certain traffic violations between March 1, 2020 and December 31, 2020 in response to the COVID-19 pandemic and subsequent closure of DMV field offices. Senate Bill 1601 prevents a police officer from issuing the following traffic citations: Unlawful parking in a space reserved for persons with disabilities under ORS 811.615; Failure to register a vehicle under ORS 803.300; Failure to pay the appropriate registration fee under ORS 803.315; Permitting unlawful operation of an unregistered vehicle under ORS 803.320; Purchase and use of an out-of-state registered vehicle by a resident under ORS 803.325; Failure to surrender out-of-state registration under ORS 803.380; Failure to submit a declaration of weight under ORS 803.440; Failure to renew vehicle registration under ORS 803.455; Improper display of validating stickers under ORS 803.560; Failure of a person to hold a trip permit when required under ORS 803.600(10). Additionally, Senate Bill 1601 directs the courts to dismiss any of the violations listed above between March 1, 2020 and December 31, 2020. Oregon residents with a vehicle registration, permit or driver license expiring between Nov. 1, 2020, and April 30, 2021, have up to three months after their expiration date without being cited by law enforcement for an expired license or tags.

The Oregon Department of Transportation and Oregon law enforcement agencies agreed to the new grace period as DMV catches up with a backlog due to COVID-19 restrictions. Under the agreement, Oregon law enforcement officers will exercise more discretion for recently expired licenses and registration before choosing whether to write a citation. Law enforcement can verify the status of a driver or vehicle registration electronically during a traffic stop.

Vehicle registrations of all classes which includes, but not limited to, mass transit vehicle registrations, apportioned vehicle registrations, fleet vehicle registrations, dealer plate registrations, temporary registrations and biennial farm exemption certificates scheduled to expire from March 16 through May 31, 2020, the expiration date is now extended through June 30, 2020. Previously, SCDMV branch offices were open Monday, Wednesday, and Friday. The Allendale and McCormick locations will continue to open on Wednesdays only. Customers must continue to schedule appointments online to maintain social distancing inside branch offices. Governor's Executive Order No. 2020-11 provided that (1) the SCDMV will suspend the collection of late fees for vehicle registration renewals and also suspend the suspension of driver's licenses for failure to pay property taxes for registration renewals that expire March 2020 through June 2020; (2) treat all traceable temporary license plates and 30-day temporary license plates with expiration dates of March 2020 through June 2020 as valid until July 1, 2020. <sup>43</sup> **South Dakota:** On July 7, 2020, the Governor issued Executive Order 2020-30 that at Section 5.A. terminates the suspension of statutory and regulatory provisions of titling and registration of motor vehicles effective August 1, 2020. South Dakotans who had been delayed in renewing their registrations during the months of March and May of 2020 will have until July 31, 2020, to complete their registration renewals. Additionally, any newly acquired vehicles, whose seller's or temporary permits expired from the end of March through today will have until July 31, 2020 to title and register their vehicle. Interest and penalties associated with the extended title and registration periods will be waived, as long as they are current before August 1, 2020. <sup>45</sup> **Texas:** On March 13, 2020, Governor Greg Abbott issued a proclamation, declaring a state of disaster for all counties in Texas due to the threat of COVID-19. Governor Abbott also issued a statement on March 16, 2020, granting a temporary extension to obtain initial registration, renewal of registration, vehicle titling, and renewal of a permanent disabled parking placard. Governor Abbott also granted a temporary extension for an individual with an expired 30-day temporary permit to obtain another permit or Texas registration. The temporary waiver applies to vehicle owners in all Texas counties as set forth in the above-referenced proclamation and statement. This temporary waiver is in effect until 60 days after TxDMV notifies the public that normal vehicle registration, vehicle titling and related services have resumed. The 60-day period will be the same for all counties. The purpose of the waiver is to prevent customers from having to physically visit a county tax assessor-collector office to obtain initial registration, to obtain a 30-day temporary permit, to transfer title; or to renew registration or a permanent disabled parking placard. Customers may continue to renew their registration online at [www.txdmv.gov](http://www.txdmv.gov). At this time, TxDMV continues to fill online registration sticker requests and process all other online services. TxDMV has informed law enforcement agencies and the offices of the county tax assessor-collectors of the temporary waiver. To preserve the TxDMV's accommodation, the Texas Comptroller of Public Accounts is providing an extension of up to 90 days past the original due date to pay the motor vehicle tax due on these purchases. The Comptroller's office is authorized to make this extension by Section 111.051(b) of the Texas Tax Code. Late penalties will be assessed as if the last day of the extension is the original due date. Moreover, an extension has been provided for vehicle inspections; when the state of emergency has passed you will have 60 days to have your vehicle inspected and complete the registration process. The temporary waiver of certain vehicle title and registration requirements, announced by Governor Greg Abbott on March 16, 2020, due to the COVID-19 pandemic, will end on April 14, 2021.
